Informative report on the processing of personal data

The Regulation (EU) 2016/679 “General Regulation on Personal data Protection” (from now on “GDPR”) states the right of any person to the protection of personal data that concern that person. As an interested party, pursuant to Article 13 of GDPR, we provide you the following information.

The Data Controller is the University of Trento, via Calepina 14, 38122 Trento, Email: ateneo@pec.unitn.it; ateneo@unitn.it. The Data Protection Officer can be contacted by the following email address: rpd@unitn.it.

The processing of personal data will be carried out on paper and / or computerized exclusively by staff authorized to process the data in respect of the tasks and functions assigned and with due regard to the principles of lawfulness, of propriety, of transparency, of expediency, of proportionality, and in order to ensure appropriate confidentiality requirements.

The data are communicated to Officina Edizioni for the publication of the paper version.

The collected data will not be transferred to non-EU countries.

The conferral of personal data above mentioned is optional but the lack of conferral means the inability to proceed with the purposes specified in the consent form that precedes.

The personal data will be stored for the time necessary to achieve the aim for which they were collected or for the time necessary to achieve the fulfilment of legal obligations. At any event the personal data will be stored for the time set out by the legislation in force and/or by the University's regulation in the field of administrative documentation storage.

The data subject is entitled to obtain from the Controller, at any moment, in the cases provided for, the exercise of the rights set out under articles 15 et seq. of GDPR, in particular the access to his/her personal data and any other information indicated in art. 15 of GDPR; the rectification of personal data when incorrect and/or the integration of personal data when incomplete; the restriction of processing of personal data, as well as the right to object to such processing and, in the cases provided for, the erasure.

For further information and the exercise of the rights involved a specific application can be sent to the controller or the data protection officer to their contact details abovementioned.

Lastly, the data subject has the right to lodge a complaint with the Personal Data Protection Authority (Garante per la protezione dei dati personali) pursuant to art. 77 of GDPR.
